DIRECTIONS FOR USE

Wear appropriate personal protective equipment (PPE) such as chemical resistant gloves, overalls and eye/face protection to protect against splashes. If in doubt speak, to your PPE supplier and show them this label/product, or call us for further advice.

Remove all loose matter and visible growth from surface to be treated. Apply generously by spray, brush or cloth and scrub as needed. Leave up to 20mins but do not allow to dry, before agitating/scrubbing and rinsing with clean water at low to medium pressure. It maybe necessary to repeat the process for heavily contaminated areas. Driveway, Decking and Patio Cleaner is not ableach so will not remove all stains. If applying to exterior surfaces, do not apply if rain is imminent. Note: Test on an inconspicuous area first to ensure compatibility.

AFTER USE

Clean application equipment with water. **APPLICATION RATE**

One litre per five square meters.
